

# School Health Management V6.5.3 Release Notes – Jan. 2024

# THE FOLLOWING SCHOOL HEALTH MANAGEMENT UPDATES ARE NOW AVAILABLE.

This release notes document is for School Health Management and Health Portal.

The release includes defect corrections and two state reports.

#### Specific updates for the Health Portal:

- The Health Check has been removed when this setting is turned off in the main application.
- For districts that are utilizing forms that are sent to the portal, the links have been corrected to open.
- When Districts add Forms for the Health Portal, the Group Forms has been corrected to send those forms to the portal when the feature is being utilized.

#### Specific updates for existing features include:

- The To Do List Days Back feature has been corrected to account for past days off in the School Closing and Activity calendar.
- The Medical Procedure widget on the Student Profile has been corrected to show PRN and Scheduled when both are selected. A correction has also been made to not show Scheduled when the schedule was deleted.
- The Medication widget on the Student Profile has been corrected to not show Scheduled when the schedule was deleted.
- The audit log has been corrected when showing changes in the Student Profile Services menu for the Signed Date field. This happens when the Service is Signed and then Unsigned.
- The About menu in the ? menu has been updated to show the last 12 months of release versions and dates.
- The Person/Student Search has been corrected to show results when searching by Last Name and will not give results for First Name.
- The Care Plans that are historical will retain the student's name and information. When opening these old care plans, they were opening in another student's name.

- The Maryland Health Immunization Certificate has been corrected for DTap-IPV (Unknown) to show vaccine dates for Polio and DTap.
- The Office Visits Incident tab, Incident Type field has been corrected so a user can deselect a list item in the field.

# Specific updates for Admin users include:

- In Care Plan and Letter Templates, the <<varicella\_doseinfo>> snippet has been corrected to not show the MMR dose for this snippet in the letter.
- The Service Agreement in the About menu has been restored.

# Specific updates for Billing users include:

- The Billing Code will populate the Medication Admins in the Quick Admin feature when this field is populated in the Maintenance screen.
- The Procedure Codes Edit screen has been corrected to save the changes on the first save.

# Specific updates for Reports:

- A new NY Asthma, Diabetes, Hypertension & Hyperlipidemia C-297 Report has been added.
  Your District Administrator will need to add this in your security role to have access to the report. The guidelines can be found in the Learning Center.
- The Prescription Maintenance and Admin Data by Examiner C-259 Report has been corrected to output data based on the schools selected in the search criteria, instead of all schools.
- The Services by Student C-260 Report has been corrected to output data based on the schools selected in the search criteria, instead of all schools.
- The Billing State Audit 4009 Report has been corrected to not show an error in the Comments field section of the report.
- The Student Service Billing Audit Report 4010 Report has been corrected to output data when events have Comments.
- The new Mass. Asthma and Diabetes Survey 5204 Report has been completed for utilization.
  Please note that your District will need to import Race and Ethnicity to populate this report.
